## **Item 5 a. i. CASG Equity Scholarships**

• For the Equity Scholarships, Nora and the AIF committee removed the requirement of students having to submit a CCR record. The scholarship's requirements were rewritten to make it easier to comprehend and for applicants to have an easier time understanding

- what is required of them.
- There are now five scholarships.
- Applicants are now encouraged to submit all information in their Academic CV in order to reduce the various documents applicants have to submit for this scholarship. Nora and her team consulted with several external partners to consult on the scholarships, specifically the Affirmative Action (now called Equity Scholarships).
  - Some of the changes that were made after the various external consultations include:
    - First, inclusivity. There were issues of inclusivity and the lack thereof, such as individuals without formal leadership roles would be unable to apply for this scholarship. There was a recognition that leadership positions can be limited, therefore, this requirement can exclude a variety of students who want to apply for this scholarship.
    - Second, Nora expressed that she wanted to create the application to reduce the situation where students feel the need to 'trauma dump' on their personal reflection. Therefore, for the personal reflection requirement for the scholarship, students can now reflect on an experience where they demonstrated their leadership qualities (for example, helping a peer in class or describing a challenge they had to overcome in their life).
    - Finally, this scholarship was identified as being complicated to apply to in contrast to the other scholarships offered by CASG. To address this problem, there were notable changes to the applications' required documents, such as expanding the requirements of references and removing the CCR requirement.
    - This scholarship will no longer be named 'The Affirmative Action Scholarship.' The new name is 'Equity Scholarships.'

    - Dakota expressed gratitude to everyone who participated in CASG's Study Snacks Campaign and 'Net Night.' Net Night was well attended by students and faculty. Due to the success of this event, CASG hopes to host a similar event and broaden its scope.
    - Currently, Dakota has spent the beginning of the semester creating a strategy to ensure the stability of CASG.
